Another Year, Another Collaborative Stage Version!

Background: Current screening recommendations for colorectal cancer (CRC) encourage initiation of FOBT, sigmoidoscopy, or colonoscopy at age 50 for persons that experience average risk, with continuation of one or more of these screening practices in accordance with recommended guidelines, until age 75 years (1). Older age is the most robust risk factor for CRC, with approximately 90 percent of California cases from 2005 -2009 diagnosed after age 49 years. Because of language and cultural barriers to screening and because persons of non-Hispanic black race experience the highest age-adjusted risk of death for CRC, Hispanic and NHB Americans are frequently targeted for intensified screening (2-3). Males also experience somewhat higher age-adjusted risk of CRC than females, although the longer life-expectancy and older age-distribution for women ensures that nearly as many women will succumb to CRC in the U.S. during 2012 as men (4).

Business Rules Management Solutions

Business Rules Management Solutions (BRMS) is a project developed by CCR to implement automatic coding error identification and correction in the Eureka Data Management System (EDMS) database. EDMS is a central registry system which houses all the cancer cases in California. This database is then used to submit California's cancer cases to SEER, NAACCR and NPCR and uses the same edit metafile that is in the hospital software edit package. This project utilizes experienced CTRs who work in collaboration with experienced software programmers.
